## SCOPE OF WORK

1. Repair of damaged exterior roof fascia.
2. Supply and replacement of ceramic tiles for wall and flooring in the 2 bathrooms.
3. Supply and replace 2 in number good brand, WC, Wash Basin with counter top and mirror, towel rail, toilet holder. 02 shower cubicles sets needs to be replaced/repaired.
4. Repair of seepage in following places: -
  - a. Kitchen wall and roof.
  - b. Guest bedroom floor and roof.
  - c. Common lobby floor in front of common bathroom on first floor.
  - d. Roof of mini dining hall.
5. Painting of roof tiles.
6. Repair of embankment of bamboo trees in the lawn.
7. Repair of covering sheets in front verandah to stop leakage. Provision of gutter/ drain to be made to prevent recurrent damage to RG area (drawing room).
8. Cleaning of stone walls.
9. Cleaning and repair of drains and gutters (8 in no.)
