## NOTICE INVITING LIMITED TENDER FOR SUPPLY OF 08 (Eight) SHREDDERS TO HIGH COMMISSION OF INDIA

High Commission of India, Nairobi invites bids from registered companies for supply of 08 (Eight) Shredders with the following specifications:

- a) Shredder with minimum security level of P-5 or above
- 2. Envelopes should indicate the name and address of the tenderer to identify the bid and to enable the bid to be returned unopened in case it is declared 'late' or 'rejected'. Offers received through Fax/E-mail or through open letter shall be ignored.

#### 10. Performance Guarantee Bond (PGB):

The successful bidder, must send the its acceptance in writing along with Performance Guarantee Bond @ 5% of the contract value shall be submitted in the form of Bank Guarantee as Performance Guarantee which should be remained in force till the Warranty period is over. If successful bidder fails to submit the Performance Guarantee Bond @ 5% of the contract value within 15 days from the date of placing of purchase order then purchase order will be canceled and EMD will be forfeited.
